(the "Company") (OTC Bulletin Board: NMTG), today announced that all the steps have been completed for the previously announced 1 for 5 reverse stock split of its common stock. In connection with the reverse split, the Company has been assigned a new stock symbol. The Company's shares were previously quoted on the OTC Bulletin Board under the stock symbol "NMTG" and are now reported on the OTC Bulletin Board under the new stock symbol "NMTR." The Company's transfer agent is currently sending shareholders information and instructions on how to exchange their present shares for new shares of the of New York Mortgage Trust, Inc. common stock.

New York Mortgage Trust, Inc. (NMTR), a self-advised real estate investment trust (REIT) engaged in the investment in and management of high credit quality residential adjustable rate mortgage (ARM) loans and mortgage-backed securities (MBS). As of March 31, 2007, the Company exited the mortgage lending business. The Company's portfolio is comprised of securitized, high credit quality, adjustable and hybrid ARM loans, and purchased MBS. Historically at least 98% of the portfolio has been rated "AA" or "AAA". As a REIT, the Company is not subject to federal income tax provided that it distributes at least 90% of its REIT income to stockholders.
