(the "Company") (Nasdaq: NYMT) announced today that its Board of Directors declared on December 21, 2009 a cash dividend of \$0.25 per share on shares of its common stock for the quarter ended December 31, 2009. The dividend is payable on January 26, 2010 to common stockholders of record as of January 7, 2010.

In addition, the Board of Directors declared a dividend of \$0.625 per share on shares of its Series A Preferred Stock for the 2009 fourth quarter in accordance with the terms of the Series A Preferred Stock. The dividend will be payable on January 29, 2010 to stockholders of record on December 31, 2009.

New York Mortgage Trust, Inc. is a self-advised real estate investment trust (REIT) that invests primarily in real estate-related assets, including mortgage-backed securities ("RMBS") issued by Fannie Mae or Freddie Mac (each an "Agency") and high credit quality residential adjustable rate mortgage ("ARM") loans, and to a lesser extent, in certain alternative real-estate related and financial assets. As a REIT, the Company is not subject to federal income tax, provided that it distributes at least 90% of its REIT income to stockholders.
